Becoming a BTWSA Member

Membership in the BTWSA organization is open and available to local unions in Ontario who may apply for and receive acceptance by vote of existing member local unions. There are currently 48 local unions that are BTWSA members.

Membership in the BTWSA entitles a local union access to experienced and professional legal representation for its members before the WSIB and WSIAT. Services are only available through referral by authorized local union officials. No service is available to any individual on any other basis and no non-members receive service.

As a not-for-profit organization BTWSA operates on a cost of operations basis. Recovery expenses are shared among member local unions. This results in affordable fees and results for participating local unions.

Our legal professionals represent injured workers in all matters relating to workers' compensation. This includes preparing and filing submissions, as well as appearances at all levels of appeals. We also assist workers in disputes over returning to work, modified duties, and other accommodation issues.

We also offer assistance with CPP, CPP-D, and EI denial appeals.
